Covenants/Bylaws Reminders

Thank you for your adherence to our Covenants and Bylaws. Thank you also for your communications to the Board. We are working to address your concerns. However, according to the Bylaws, we need to ask that all correspondence be signed. We have not and will not identify any member that sends correspondence to the Board. Chances are if you have a concern, there are others that share that concern.

Association Dues

POA dues are due on July 10th.

To help residents avoid paying a penalty for late Association Dues as mandated by the Covenant, we are providing the following reminder of the Association Dues fees and penalties schedule:

Association dues can be paid quarterly, semi-annually or annually.

Failure to pay within the 10 day period will result in a late fee of Twenty Five dollars (\$25.00) & penalty & interest costs which will accrue at a rate of 1.25% monthly being imposed by the Townhouse Property Owner's Association.

Example of a late fee calculation applies to end and center units, end unit shown as an example.

- <u>If late first month</u> \$363.00 quarterly dues plus \$25.00 penalty x 1.25% interest. Association dues of \$363.00 plus \$25.00 penalty = \$388.00 x 1.25% \$4.85 equals \$392.85
- If late second month \$392.85 x 1.25% (\$4.91) interest equals \$397.76
- <u>If late third month</u> \$397.76 x 1.25% (\$4.97) interest equals \$402.73
- Continues to accrue each month until association dues & penalty & interest are paid.




★ Vehicle Operation

Owners, Residents and Guests must operate their vehicles in a safe manner at all times within the development. The speed shall not exceed 20 miles per hour.

№ Please remember:

- Any landscaping that needs to be replaced must be replaced in kind. (Covenants, p.7)
- Please help by watering newly planted grass and shrubs. (Landscaping Regulations)
- Lawn ornamentation/statues shall not be displayed in the front or side yards or mulch beds. One piece of ornamentation may be displayed in the rear yard. (Covenants, 6.v, p.8)

★ Insurance Compliance Committee

The Insurance Compliance Committee was established to ensure all owners carry the required insurance limits on their homeowner's policy. On the renewal date of your Home Owner's policy, Joe Hazzouri, the Chairperson, asks that a hard copy of the certificate be mailed or dropped off at the POA Board's mailbox (POA #13). (Covenants, P. 10)

★ Architectural Committee

Any exterior alterations must be approved by the Landscaping or Architectural Committee and then the Executive Board. Alterations include but are not limited to extra plantings, storm doors and patios.



Holiday Refuse Schedule

Six major holidays will postpone your scheduled refuse pick-up day to the following day if they fall on a weekday.

For example, next week July 4th falls on a Wednesday, so trash for next week will be delayed a day and picked up on Saturday.

The holidays are as follows: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving and Christmas.

Storm Doors

It is advisable to leave your storm door window open due to excessive heat build up which can cause possible damage to the door.



Dog Walking

If you hire a dog walker, please inform them of the Association's rules and ensure they avoid lawn areas around the Townhouses and use common areas and remember to clean up.



Comcast

As some of you may know, the Board was approached about investigating a Bulk Rate for Comcast services. In order to do this, it would be necessary for the Association to contract with Comcast for all members and then increase dues to pay for the services. Since neither the Covenants nor the By Laws, which list the responsibilities of the Executive Board, have a provision that explicitly allows the Board to do this or to use dues for this purpose, we took the request very seriously. Additionally, we are always looking for cost cutting methods that will benefit all Members. After investigating, we decided that at this time, it was not in the best interests of the Community for following reasons:

- For the members that are away for months and get a "seasonal" rate, it would mean they would probably pay more. As noted above, since there is no provision for the Board to ask some members to pay more dues than others, we are very reluctant to do this.
- Since this involves dues, all members would have to be contacted to see what their Comcast package includes so that we can provide members with the maximum benefit and similar service. Informally pooling residents told us that not everyone has the same package. Surveying residents to see if they are interested would not give us the information needed for pricing. All residents would be covered under the Bulk Rate package. While not impossible, it would be very difficult to negotiate a package that would please everyone.
- For those residents that currently have bundled service or want services they have now that are not provided in the bulk rate package (additional TV boxes, HD, DVR, premium channels, telephone), they would be billed individually for the extra services. There is no additional bundling of services not covered in the Bulk rate.
- There was no guarantee by Comcast that all residents would save money.

Hillside Park is a multi-faceted regional recreation facility on 100 acres of former state-owned farm land on PA Route 307, at 1188 Winola Road, in South Abington Township.

The park is bordered by the Clarks Summit State Hospital and the Scranton Country Club, and contains the Abington Senior Center and Eston Wilson Lake located on its property.

The park is home to the Abington Youth Soccer League, Abington Travel Soccer, Abington Girls Softball League, Abington Junior Comets Football and Cheerleading and Abington Pick-Up Soccer.

Sports facilities include 2 softball fields, the grass surface Stroney Soccer Field, and a lighted, synthetic-surface soccer/football field.

Hillside Park contains the Abington Community Garden, the Abington Dog Park, a Lackawanna County Boundless Playground, the lake for public fishing with two handicapped accessible fishing piers, picnic tables, a lighted pavilion and walking trails. Selected trails are paved or planked for inclusive accessibility, and there is an all-accessible rest room building.

The park is managed by the Abington Area Joint Recreation Board (AAJRB) on behalf of five funding municipalities with assistance from Lackawanna County, state and foundation grants and private donations.

South Abington Township was created in 1867 when the larger Abington region was split into north and south parcels. It is the largest municipality in "The Abingtons" and third largest in Lackawanna County. The Township celebrated its 150th Anniversary in 2017.

The boroughs of Clarks Summit and Clarks Green (which are surrounded by South Abington) were later carved out of this southern region of the Abingtons; thus the Township's slogan, "Gateway to the Abingtons".
