- ★ subitem i: No open fires of any kind shall be permitted except those confined within a metal brazier, grill or similar cooking device, all of approved design. No leaves, trash, garbage or other form of refuse shall ever be burned at any townhouse.

Homeowners' Checklist When House is Vacant

Disconnect all hoses from the hose connections and drain water from hoses.
During cold weather months, even though the hose connections are freeze resistant, if the hoses are not removed, the water will not drain and freezing will occur. This will cause considerable damage to the plumbing and also the interior of your home.



- Set heat at 58 degrees.
- ✓ Unplug hot water heater from the outlet.
- ✓ Open all cabinet doors in vanities and under kitchen sink.
- ✓ Make sure all interior doors are left open (closets, baths, powder rooms, etc.)
- ✓ Turn off water supply in foyer closet by turning the valve a ¼ turn on the yellow handled valve. Make sure foyer closet doors are left open.
- ✓ Install new furnace filter prior to departure.
- ✓ Turn off the ice maker in the refrigerator.
- ✓ Have a neighbor or friend check on the house, especially in times of extreme cold.

Note: It is a good idea to turn off the water supply in the foyer closet when your home is vacant to avoid possible leaks and damage.

HVAC - Summer and Winter Balancing

The dampers are marked in the mechanical room. The dampers should be set to summer mode upon the need for air conditioning. Also, set to winter mode when heating is required.

Valley HVAC provides this service of damper balancing in their yearly, optional service contract. The service contract includes two visits (one at the start of the heating season and one at the start of the cooling season). The service contract is STRONGLY encouraged after the original warranty period has expired.

Also, please note once your warranty has expired, Valley HVAC will not respond to a service call during a busy time (heat wave or period of extended cold) if you do not have the service agreement.

In the event of a service call by any of the contractors, after the warranty has expired, the home owner will be charged an additional fee for a service call for nights and weekends. Therefore, if a service call can be performed during business hours of Monday – Friday; it will be much more economical.

The above Contractors performed the work in your home during construction. They will assist you with service once the warranty period has expired.



- 1. No hanging baskets or other objects are to be attached to the buildings.
- 2. Nothing can be placed in the lawn, including plants, that would interfere with lawn mowing.
- 3. Plants in pots are allowed on patios, porches, sides of driveway next to garage and in the mulch beds.
- 4. Maintenance of flowers or shrubs planted in mulch beds are the responsibility of the owners; the POA is not responsible for any damage done by mulching.
- 5. Planting around the back of any unit and alongside the porch on an end unit is allowed. The width of the bed from the building must be no more than two feet. Any mulch used must conform to the color used by the landscaper.
 - a) Beds must be edged by the owner.
 - b) No vegetables may be planted in the ground. Any vegetables or herbs must be planted in pots and kept on the back patio.
 - c) Maintenance of these plantings is the sole responsibility of the owner. These responsibilities transfer to all subsequent owners of the unit.
- 6. Only four types of shrubs are acceptable in front of the units. These are: spirea, boxwood, dwarf barberry and holly. Should one type of these plants continue to fail, it may be replaced with another from the acceptable category. End units also have burning bush on the sides which may only be replaced in kind.
 - a) The developer is responsible for replacement for one year after initial planting.
 - b) The POA is responsible for replacement during year two.
 - c) The owner is responsible for replacement thereafter. The owner has the option of replacing the plant(s) or may request this be facilitated by the POA landscape committee and done by the landscape company at the owner's expense.
 - d) If plants are not replaced within one month (during the growing season), the owner will receive a notice from the landscape committee; if replacement has not occurred within two weeks after this notice, the committee will have the plant replaced at the owner's expense.
- 7. It is the owner's responsibility to water all newly planted grass and shrubs.
- 8. Planting in the common areas by owners is discouraged and may only be done with the authorization of the Executive Board and with the understanding that maintenance of such planting is the responsibility of the owner and must be conveyed to subsequent owners on sale of the property.
