# Just a friendly reminder

#### **Vehicle and Parking Reminders**

The POA Board would like to again remind all owners and residents of our vehicle and parking regulations, as found in our Covenants:

#### 11. Unit Restrictions

**f.** All Townhouse owners and/or residents are required to utilize their garage and/or driveway for vehicle storage. No owner or resident may use the roadway for their vehicle storage. Street parking is intended to be utilized for short term visitor's\* parking only and when needed. The number of vehicles allowed for owners and residents shall be limited to **two (2)** vehicles per center unit. Owners/Residents with a two (2) car garage shall be limited to **three (3)** vehicles per unit. There are no exceptions to these regulations.

\*A visitor or guest is someone who stays at the townhome less than **14 days** and does not use the townhome as his/her official address.

#### 12. Parking restrictions

- **a.** Street parking must allow for the passage of emergency vehicles.
- **b.** Parked vehicles must be no closer than fifteen (15) feet on both sides of a fire hydrant or mailbox.
- **c.** No parked vehicle may impede the safe movement of traffic or obstruct the view of motoring traffic.
- **d.** All vehicles must be parked or operated on the community's roadway, driveways or garage.
- **e.** No vehicles should be parked on the grass or curbs due to the damage this causes.
- **f.** Owners, residents and guests must operate their vehicles in a safe manner at all times in accordance with all state and local traffic laws and as conditions allow. However, the speed shall not exceed 20 miles per hour.

#### 9. Miscellaneous Regulations

- **f.** No commercial trucks, motor homes, recreational vehicles, watercrafts on or off a trailer, trailers of any type, non-operating vehicles licensed or not and/or unlicensed vehicles, are allowed on the premises of South Abington Woods Phase II.
- **g.** No vehicles with commercial signage shall be parked on any roadway or driveway within the community. This regulation does not apply to commercial vehicles making deliveries or utilized to perform work or services at residence.
- **m.** Owners shall not be permitted to repair, dismantle or reconstruct any type of motor vehicle or truck at a townhouse or in the subdivision.

In addition, during periods of snowfall, no vehicles may be parked on the roadway.



#### EXTERNAL MODIFICATION PERMIT

Any external modification to units must be approved by both the Architectural Committee and the POA Executive Board.

Any external modifications extending into the common areas must be approved by both the Landscape Committee and the POA Executive Board.

#### Procedure for changes to the exterior of the building (e.g. storm doors, ramps, sunrooms):

- 1. Homeowner must contact Architectural Committee for approval.
- 2. Plans and contract must be approved by the Architectural Committee and the POA Executive Board <u>before</u> work is begun.

# Procedure for changes to the exterior of the building impacting common property (e.g. walkway modification):

- 1. Homeowner must contact Landscaping Committee for approval.
- 2. Contractor must submit proof of liability insurance.
- 3. Plans and contract must be approved by the Landscape Committee and the POA Executive Board <u>before</u> work is begun.
- 4. Homeowner is responsible for rectifying any lawn damage.
- a. Replacement seeding must be the same grass as that currently planted.
- b. Seeds must be covered by straw, not hay.
- c. Homeowner will be responsible for watering newly seeded areas.
- d. Any drainage problem resulting from construction is the responsibility of the homeowner.
- e. POA is NOT responsible for repair or maintenance of the modification.



#### **Scranton Iron Furnaces**



Located near the Steamtown National Historic Site, the Scranton Iron Furnaces represent the early iron industry in the United States. The four massive stone blast furnaces are the remnants of a once extensive plant operated by the Lackawanna Iron & Steel Company. Started in 1840 as Scranton, Grant & Company, the firm had the largest iron production capacity in the United States by 1865. By 1880 it poured 125,000 tons of pig iron, which was converted in its rolling mill and foundry into T-rails and other end products. In 1902, the company dismantled the plant and moved it to Lackawanna, New York to be closer to the high-grade iron ores coming out of the Mesabi Range.

The Scranton Iron Furnaces educates the public about the site of the Lackawanna Iron and Coal Company and its impact upon the nation's industrial revolution demonstrating the relevance of industrial history in our lives. The Scranton Iron Furnaces are administered by the Pennsylvania Historical and Museum Commission and are actively supported by the Anthracite Heritage Museum and Iron Furnaces Associates which is a non-profit community-based organization.

The Scranton Iron Furnaces, situated in a historic park setting, are open to visitors year round from dawn to dusk. In the summer months facilities are available for picnics.

Accessible by car or a Historic Trolley ride, the Visitor Center, which is open on a seasonal basis April through October from 10:00 a.m. to 4:00 p.m., contains exhibits on iron and steel making, a small gift shop and offers an interpretive tour. Call ahead (570-963.4804) for the days and hours of operation.
