## 2024 Painting Schedule

The Association has contracted with David Merkel to perform this year's round of exterior painting. The units that are scheduled to be painted are listed below.

The painting includes shutter painting, entrance door painting, painting of the columns, garage doors, windowsills, gas lines and meters.



The work is scheduled to begin June 17<sup>th</sup> and take a few weeks to complete. Once completed, the owners who received the painting will be invoiced for the work.

Later in the summer the contractor will be back on property to continue the list from last year that they were unable to complete. We will provide a list of units that will be done later this year once we have the schedule.

## **Association Regulation Reminders:**

Over the past few months, we've had to send a handful of reminders out regarding personal belongings in the common areas. These personal belongings include decorative flags, lawn ornaments, bird baths, dog waste containers, etc. We want to remind all owners that the governing documents specify no personal belongings can be placed in the common areas including the front mulch beds. In addition, no flags or banners can be displayed except for an American flag. The Covenants define these regulations, specifically reading:

- 5. Other than an entry security camera, small signs stating the Unit street number and a security service, and solar walkway lighting, no flags, banners, pennants, signs, decorative lights, wires, television or radio reception devices, or any unsightly objects or devices of any kind shall be placed or maintained upon a Unit or Unit yard, tree, road, or Common Area, nor in a Unit so as to be visible from the outside, except:
- a. An American flag may be displayed at the entry area of a Unit and must adhere to Federal Code and Pennsylvania Law. A flag no larger than 12"x18" supported from a banner stand is preferred and free-standing flag poles are not permitted. No flags may be displayed on Common Areas.

## **Landscaping Update:**

It appears the rainy season has finally come to an end. Over the past few months, we have seen unprecedented growth of not only the lawns but the shrubs and bushes as well.

With the rain and the quick growth our shrubs and bushes need trimming about a month sooner than normal.



AOS scheduled shrub trimming for mid-July, however, the staff is considering moving the schedule up to do the trimming sooner.

We understand some areas are very overgrown and we assure you we are working diligently with the landscaper to have the service performed as soon as possible.

Some of the bushes have not yet blossomed, which means they should not be trimmed as it is detrimental to the plant.

We will continue to work with AOS to have this service performed in a reasonable time while preserving the beautiful landscaping we have.

Board volunteers are needed for the upcoming November election. Our Board Secretary is retiring in January. Please consider volunteering for the position.

#### **Board of Directors Overview**

#### 1. Structure

South Abington Woods Phase II Property Owners Association

The Board of Directors consists of seven (7) unit owner volunteers, elected to govern and manage the affairs of the Association in accordance with the Association's Covenants, Bylaws and Rules & Regulations.

The Board also oversees and acts as liaison to various committees and the property management company.

#### 2. Authority

The Board has all the authority and rights necessary to administer the Association's affairs as set forth in the Bylaws.

#### 3. Meetings

The Board meets in January of each year for an organizational meeting, then as often as necessary but no less than every other month. A special meeting may be called at any time upon the request of the Board Chairperson, or any two (2) Board members.

## 4. Responsibilities

Directors attend Board meetings (typically via Zoom) and vote upon any matters before the Board. Directors may also communicate regarding various issues between formal meetings.

## **5.** Compensation

Board members receive no compensation for their duties.

## 6. Qualifications

To qualify as a Board Director, a unit owner must be in good standing, not be involved in litigation with the Association, not have a familial relationship nor be a co-owner with another sitting Director, nor be a convicted felon.

#### Board of Directors Overview cont.

#### 7. Officers

At the first meeting of each year the Board votes amongst themselves by a simple majority to fill the following Officer positions:

- Chairperson Presides over Board meetings.
- Treasurer Receives and disburses Association funds.
- Secretary Records and preserves the minutes and documents of meetings, communicates with the members and maintains a resident directory.

Officers fill their elected positions until the end of their current term. Officer positions have no term limits and there is no prohibition of incumbents being re-selected by the Board.

#### **Standing Committees**

#### 1. Landscaping Committee

The Landscaping Committee coordinates with the property management company to oversee the overall care and maintenance of shrubs, trees, plantings and lawn areas of the development, and obtains bids for contracted landscaping services.

#### 2. Snow Removal Committee

The Snow Removal Committee coordinates with the property management company to monitor the work of snow removal services and obtains bids for contracted snow removal services.

#### 3. Architectural Committee

Inactive. Activities handled by property management company. 4. Insurance Compliance Committee: Inactive. Activities handled by property management company.



#### **Strawberry Peach White Wine Slushie**

1 bottle of white wine

2 cups of frozen peach and/or mango slices

1 cups of frozen strawberries

3 cups of ice cubes

Blend 2 cups of white wine with about 2 cups of frozen peaches and 2 cups of ice cubes.

Pour into four glasses.

Blend 1 cup of white wine with about 1 to 1 ½ cups of strawberries and 1 cup of ice.

Pour it on top of the peach slushy.



#### **Orange Slushy**

1 2/3 cups orange juice, divided 12 ounces vanilla bean yogurt 1 tablespoon honey

Pour 1 1/3 cups orange juice into an ice cube tray; freeze until solid, about 3 hours.

Empty cubes into a blender and combine with the remaining 1/3 cup orange juice, yogurt, and honey. Blend until smooth.

Serve into cold tumbler glasses and enjoy!

Boozy option: Add in a splash of vodka or rum for an adult slushy.



## Easy Malibu Pina Colada Recipe

2 oz. rum

1 oz. cream of coconut

3 oz. pineapple juice

½ cup frozen pineapple chunks

½ cup ice

1/8 fresh pineapple chunks and maraschino cherries for garnish

Combine the frozen or fresh pineapple, coconut rum, cream of coconut, pineapple juice, and ice in a blender.

Set to medium and blend until ice is crushed and the drink is smooth. If needed, add additional frozen pineapple or ice for a thicker consistency or thin out with a splash of pineapple juice.

Garnish your piña colada with fresh pineapple chunks and maraschino cherries.
